
13. Describe Proposed or Completed Operation (clearly state all pertinent details, including estimated starting date of any proposed work and approximate duration thereof. A bond log was ran on the East Pecos Fed 22-1H. TOC was indicated at 4160 feet (9 5/8 inch casing shoe is at 2840 feet). In order to provide cement tie-back conforming to BLM standards, it is proposed to pump 250 sks of 35:65 Poz ?C? with 5% PF44 (Salt), 6% PF20 (Bentonite Extender), 25% PF46 (Anti Foam), 2% PF13 (retarder) mixed at 12.6 ppg (2.03 cf/sk) down the 5 1/2 inch x 9 5/8 inch casing. This slurry will be displaced to 2500 feet.
