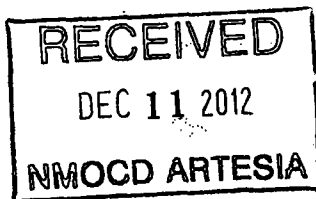

Run 5 1/2" csg. pkr, cementing sleeve, and 592' of 4" flush pipe. Set pkr. at 550'. Drop ball and circulate cement to surface. WOC 24 hrs. and test to 2000 lbs. Return to production.
