1. Devon Energy had contracted Talon/LPE to reclaim the closed drilling pit at the Hackberry 18 Federal No. 1, an active well.

2. On April 3, 2011 Talon personnel mobilized to the site to begin excavation of the impacted areas as indicated in the approved work plan. As directed by the BLM, the impacted soil within the areas of the pit were excavated and transported to a NMOCD approved solid waste disposal facility, CRI, pursuant to the work plan. The excavated areas were left open until approval for backfilling was obtained from the BLM.

3. The surface of the closed drilling pit area was bladed to prepare for the installation of a liner. Rock and debris were deep buried into the drilling reserve pit area. A composite 20 millimeter liner measuring 230-feet long by 150-feet wide was installed over the closed drilling pit area. The edges of the liner was keyed a minimum of 3-feet deep into a trench excavated at the boundaries of the closed drilling pit area.

4. A minimum of 2-foot of new soil was placed over the top of the 20 mil liner in closed drilling pit area. The soil lift was contoured to match the surrounding terrain.

5. The location was then cut, ripped and windrows were constructed. A 1-foot berm was constructed up gradient of the location to divert run off waters for erosion control. The location was seeded on 7/6/12 using a 50/50 mix of BLM seed mixture #2 and #4.
