12/11/12 – Loaded hole with fresh water and tested to 500 psi. Mixed and pumped 80 sx Class "C" Neat cement. WOC. Tagged at 151'. Perforated 4 holes at 150'. Pressured to 500 psi. No pump in. Circulated cement to surface. ND BOP. Topped out casing.

12/12/12 – Dug out cellar and cut off wellhead. Installed dry hole marker. Filled cellar and cut anchors. **WELL IS PLUGGED AND ABANDONED.**
