Devon Energy Production Company, L.P. respectfully requests to flare the Shaqtus Tank Battery located in Section 35, T21S, R31E, Eddy County, NM, where these five wells enter: API #: 30-015-39819; 30-015-39896; 30-015-39994; 30-015-40012; 30-015-40106.

This exception is requested for the following reasons: At the moment, pressure rating of the pipeline segments are insufficient to take all the produced gas in the area. Requesting flare permission for excess gas until alternate gas markets can be accessed or pipeline infrastructure improvements are completed. Total gas deliverability at this battery is in excess of 2MMCFD; Devon will flare only as much as required to avoid over-pressuring the pipeline.
