
12/17/12 - NU BOP. RIH with bit and scraper to 1271'. Set a CIBP at 1230'. Loaded hole with 20 bbls, no test. Pumped 125 sx Class "C" Neat cement. WOC. Tagged at 515'. Tested to 500 psi. Pumped 50 sx Class "C" Neat cement and circulated to surface. ND BOP. Topped out casing.

12/18/12 - Top of cement 20' down in casing. Mixed and pumped 5 sx Class "C" Neat, casing full.

12/26/12 - Dug out cellar and cut off wellhead. Installed dry hole marker. Filled cellar. **WELL IS PLUGGED AND ABANDONED.**
