

Mixed @ 15.6#/g w/1.20 yd. Plug down @ 2:30 PM 11/19/12. Circ 28 sks of cement to pit. WOC. At 9:30 PM 12/01/12, tested csg to 1500# for 30 mins, held OK. Drilled out with 6 1/8" bit.
