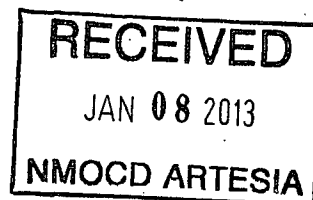

Alamo Permian Resources plans to test the gas productivity of the TEK KEYES B #9 well by installation of a tubing string, new wellhead, and compression. The purpose of the test, over a 3 month period, will demonstrate the productivity and commerciality of production and potential of the KEYES A wells. If the test well is incapable of economic production, all five TEK KEYES B & A wells will be PA'ed.
