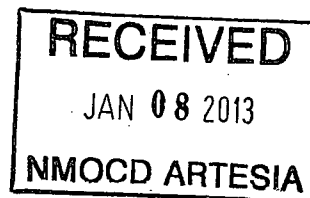

The purpose of the test, over a 3 month period, will demonstrate the productivity and commerciality of production and potential of the TEK KEYES B wells. If the test well is incapable of economic production, all five TEK KEYES B wells will be PA'ed.
