Tagged at 2052' and worked down to 2060'. Loaded casing with 40 bbls for a total of 85 bbls down

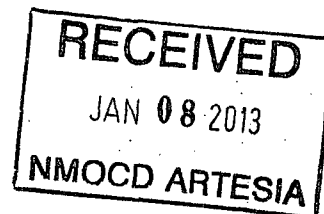
hole. Pressured up to 800 psi. Bled off slowly. Washed down to 2075'. Lost circulation and fell
