

Pursuant phone conversation, plan for finishing the cmt of 9-5/8" interm csg for the Raven Federal Com #1H well:

1. 13-3/8" surf csg set @ 450' & cmt back to surf. 9-5/8" interm csg set @ 3509' & cmt w/1300 sx lead cmt (12.6 ppg, 2.07 yld) & 510 sx tail (14.8 ppg, 1.33 yld). Well flowing 50 bph @ start of cmt job. Cmt did not circ to surf during 9-5/8" cmt job. Well shut in for 4 hrs after cmt job then opened up, flow @ 159 bph. After waiting several more hrs, temp survey was run, TOC @ 1570'. Shut in pressure for 9-5/8" x 13-3/8" annulus: 214 psi. A 3 bpm inj rate can be established down this annulus @ 271 psi.
