RIH & set 8-5/8' 32# J55 LTC csg @ 4500', cmt w/ 960sx (316bbl) Light PPC w/ additives followed by 300sx (71bbl) PPC w/ additives, circ 349sx (115bbl) cmt to surface. WOC. Test BOP's @ 250# low 5000# high. 1/12/13 RIH & tag cmt @ 4412', circ hole, pressure test csg to 22624# for 30 min, tested good.
