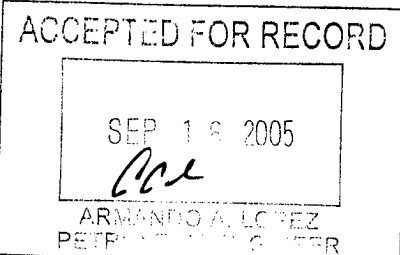

8/10/05 Set nickel plated packer and 2-7/8" IPC tubing at 6110'. Tested packer to 500 psi for 30 min, held OK.

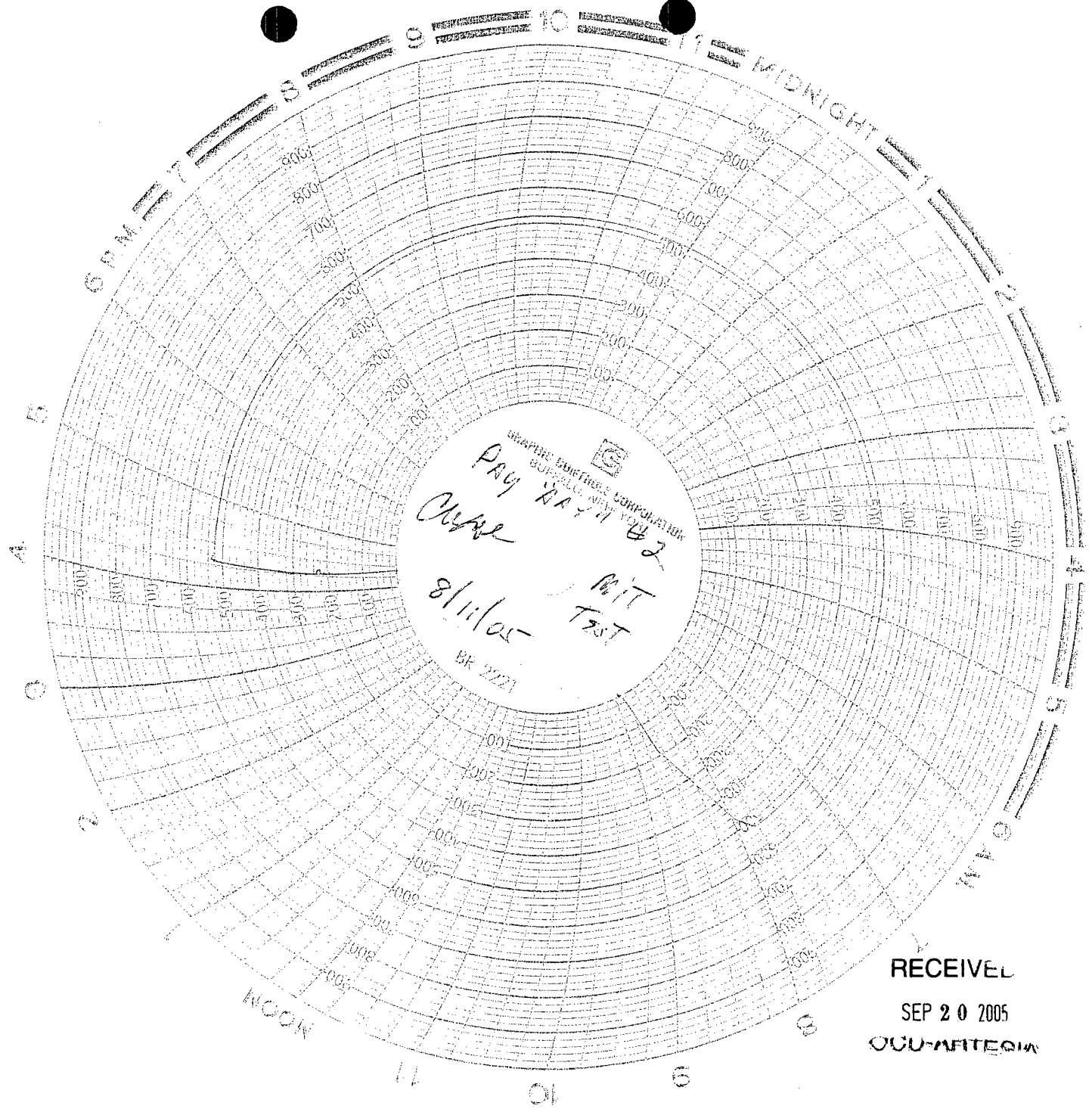
