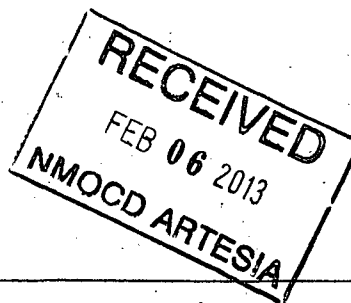

Due to two facilities sharing a single pad, the entire location is needed to be able to conduct daily operations.
