

Tail w/300 sks Class C w/1% CaCl2 Mixed @ 14.8 #/g w/1.33 yd. Plug down @ 6:45 AM 01/18/13. Circ 82 sks cement to pit. WOC 18 hrs. At 7:45 AM 01/19/13, tested csg to 1500# for 30 mins, held OK. Drilled out with 6 1/8" bit.


