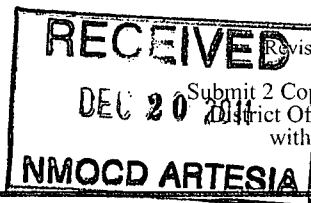

If initial analytical results for TPH & BTEX are under RRAL's a Final Report, C-141 will be submitted to the OGD requesting closure. If the analytical results are above the RRAL's a work plan will be submitted. Depth to Ground Water: >100' (approximately 130', Section 21-T19S-R25E, per NMOCSE), Wellhead Protection Area: No, Distance to Surface Water Body: >1000', SITE RANKING IS 0. Based on site ranking of "0", and impacted soils excavated/hailed and enclosed analytical results Yates Petroleum Corporation requests closure.
