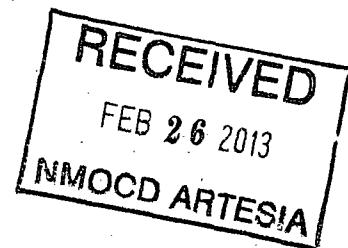

 8. Return well to production.
 9. RDMO DDP. Clean location.
