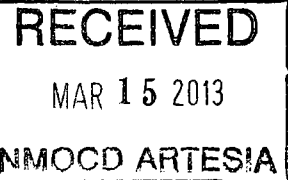
Initial reclamation sundry dated 4/10/12 denied on 5/17/12. Jennifer Van Curen requested the location be re-ripped and re-seeded.
