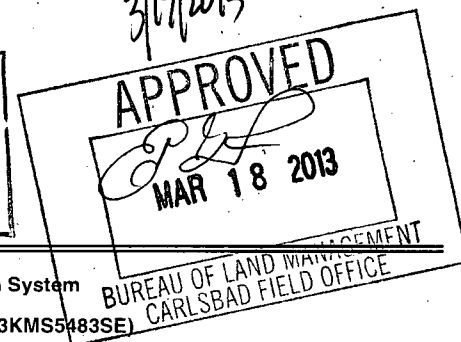
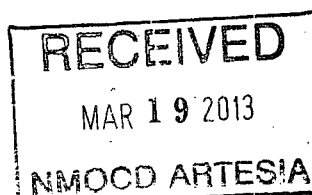

Bond log indicates TOC at 3,700 feet, 9-5/8 inch casing is set at 3,598 feet. Therefore, it is proposed to bullhead squeeze 85 sks 35/65 Poz Class C with 5% BWOW PF44 salt, 6% PF20 gel, .25 pps PF46 antifoam, .2% PF13 retarder mixed at 12.9 ppg (1.89 cf/sk). Displace cement with 143 bbls water.

Cement should tie-back at least 300 feet into previous casing string. Operator shall provide method of verification and RUN a CBL.
