BOPCO, L.P. is requesting approval to temporarily abandon the PLU 348H wellbore. We encountered mechanical issue with the 9-5/8" casing, and cemented a RTTS packer and 500' of drill pipe in the hole trying to preform a casing squeeze. The wellbore will be secured by pumping a 500' cement plug inside the 53.5 ppf, HCL-80 casing from 9,600' to 9,100'. The wellhead will be secured with a blank flange and a gause.

BOPCO will set a cased hole whipstock and turn the wellbore into a lateral targeting one of the following formations Bonespring, Wolfcamp, or Delaware. A revised directional plan will be submitted along with a revised drilling plan of the formation we plan to target. BOPCO will move a rig onto the location by August 2013 to resume drilling operations. The PLU 348H will be completed and producing by December 2013.
