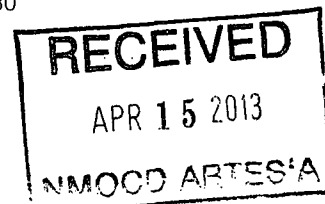
1/7/13 - As per BLM RIH open-ended to 8640 ft. Spotted cement plug across Morrow top. Pumped 30 sx Class H at 15.6Lb plug. Reverse circulated 44 bbls.

1/8/13 - Tagged cement top at 8264 ft. BLM was not there to witness tag. Contacted Joe Salcido, confirmed cement was high enough. Perforated Cisco 7226 ft - 7286 ft (70).

1/9/13 - RIH to bottom perf at 7286 ft. Spotted 2 bbls. Acidized with 4000g 15 percent NEFE HCL acid. Dropped 140 ball sealers, balled out with 112 balls on formation.

1/13/13 - Perforated Cisco 7364 ft - 7664 ft (58). m m

1/14/13 - Loaded casing with 31 bbls KCL. Dropped 128 ball sealers, saw good ball action, did not ball out. Pumped 128 bbls 15% NEFE HCL acid with surfactants total. Flushed to bottom perf with 34 bbls KCL.

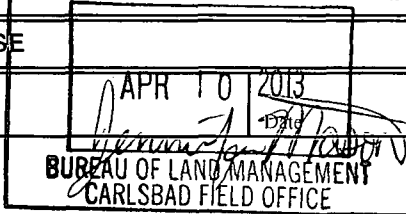
