 4/11/13 - WOC 42 hrs. Reduced hole to 12-1/4 inch and resumed drilling.  
 4/12/13 - TD 12-1/4 inch hole to 1916 ft.  
 4/13/13 - Set 9-5/8 inch 36Lb J-55 LT&C casing at 1916 ft. Cemented with 520 sx Class C + 3Lb/sx D042 + 5% D044 + 0.125Lb/sx D130 + 0.2% D046 + 3% D020 (yld 1.80, wt 13.5). Tailed in with 180 sx 50/50 Poz C + 3Lb/sx D042 + 5% D044 + 0.125Lb/sx D130 + 0.2% D046 + 0.2% D065 (yld 1.36, wt 14.2). Circulated 203 sx to pit.  
 4/14/13 - Tested casing to 1500 psi for 30 min, good. WOC 41 hrs. Reduced hole to 8-3/4" and resumed drilling.
