Spudded well on 4/5/13. Drilled 12-1/4" hole to 410'. Set 8-5/8" 24# J-55 csg @ 391'. Cmted w/335 sx (449 cf) cl "C" cmt w/2% CaCl₂ & 0.125# C/F. Circ 92 sx cmt to pit. On 4/7/13, pressure tested 8-5/8" csg to 1500 psi - dropped to 1425 psi in 30 min.

Drilled 7-7/8" hole to TD4600' on 4/10/13. Ran open hole logs. Set 5-1/2" 17# J-55 production csg @ 4595'. Cmted w/lead 300 sx (573 cf) 35:65 poz "C" cmt w/5% salt, 0.35% R-3, 6# CD-32, 5# LCM-1, & 1/4# cello flake & tailed w/600 sx (798 cf) cl "C" cmt w/0.25% R-3, 0.005# SF, & 0.25# Cello Flake. Circ 148 sx cmt to pit. Released drilling rig on 4/12/13. Plan to pressure test 5-1/2" csg during completion operations.
