

The SWD waterline will begin at the PLU Big Sinks 14-25-30 battery on northside of pad and run north for +/- 170.5' then turn northeast and parallel exsiting ROW for +/- 4,209.6' in section 14-T25S-R30E, and cross County Road 786 (Buckjackson Road), continue northeast in section 13-T25S-R30E for +/- 326.5' and connect to proposed SWD waterline. the plats are attached for review.






