Drilled 7-7/8" hole to TD4604' on 4/26/13. Ran open hole logs. Set 5-1/2" 17# J-55 production csg @ 4585'. Cmted w/lead 300 sx (570 cf) 35:65 poz "C" cmt w/5% PF44, 6% PF20, 2% PF13, 0.125# PF29, & 0.25# PF46 & tailed w/700 sx (938 cf) cl "C" cmt w/0.5% PF13, 0.2% PF167, 0.2% PF065, 0.125# PF29, & 0.4# PF46. Circ 117 sx cmt to pit. Released drilling rig on 4/28/13. Plan to pressure test 5-1/2" csg during completion operations.
