Drilled 7-7/8" hole to TD4650' on 4/18/13. Ran open hole logs. Set 5-1/2" 17# J-55 production csg @ 4650'. Cmted w/lead 300 sx (570 cf) 35:65 poz "C" cmt w/5% salt, 5# LCM-1, 0.2% R-3, & 1/4# cello flake & tailed w/575 sx (765 cf) cl "C" cmt w/0.6% R-3, & 0.25# Cello Flake. Circ 68 sx cmt to pit. Released drilling rig on 4/20/13. Plan to pressure test 5-1/2" csg during completion operations.
