Spudded well on 4/25/13. Drilled 12-1/4" hole to 431'. Set 8-5/8" 24# J-55 csg @ 431'. Cmted w/280 sx (378 cf) cl "C" cmt w/2% CaCl<sub>2</sub> & 0.25# C/F. Circ 25 sx cmt to pit. On 4/27/13, pressure tested 8-5/8" csg to 1500 psi for 30 min-OK.

Drilled 7-7/8" hole to TD4700' on 4/30/13. Ran open hole logs. Set 5-1/2" 17# J-55 production csg @ 4694'. Cmted w/lead 325 sx (621 cf) 35.65 poz "C" cmt w/5% PF44(BWOW), 6% PF20, 0.2% PF13, 0.25# PF29, 0.25# PF46, & 3# PF42 & tailed w/650 sx (868 cf) cl "C" cmt w/0.4% PF13 & 0.125# CF. Circ 235 sx cmt to pit. Released drilling rig on 5/1/13. Plan to pressure test 5-1/2" csg during completion operations.
