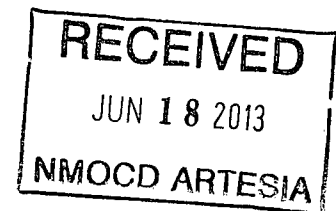

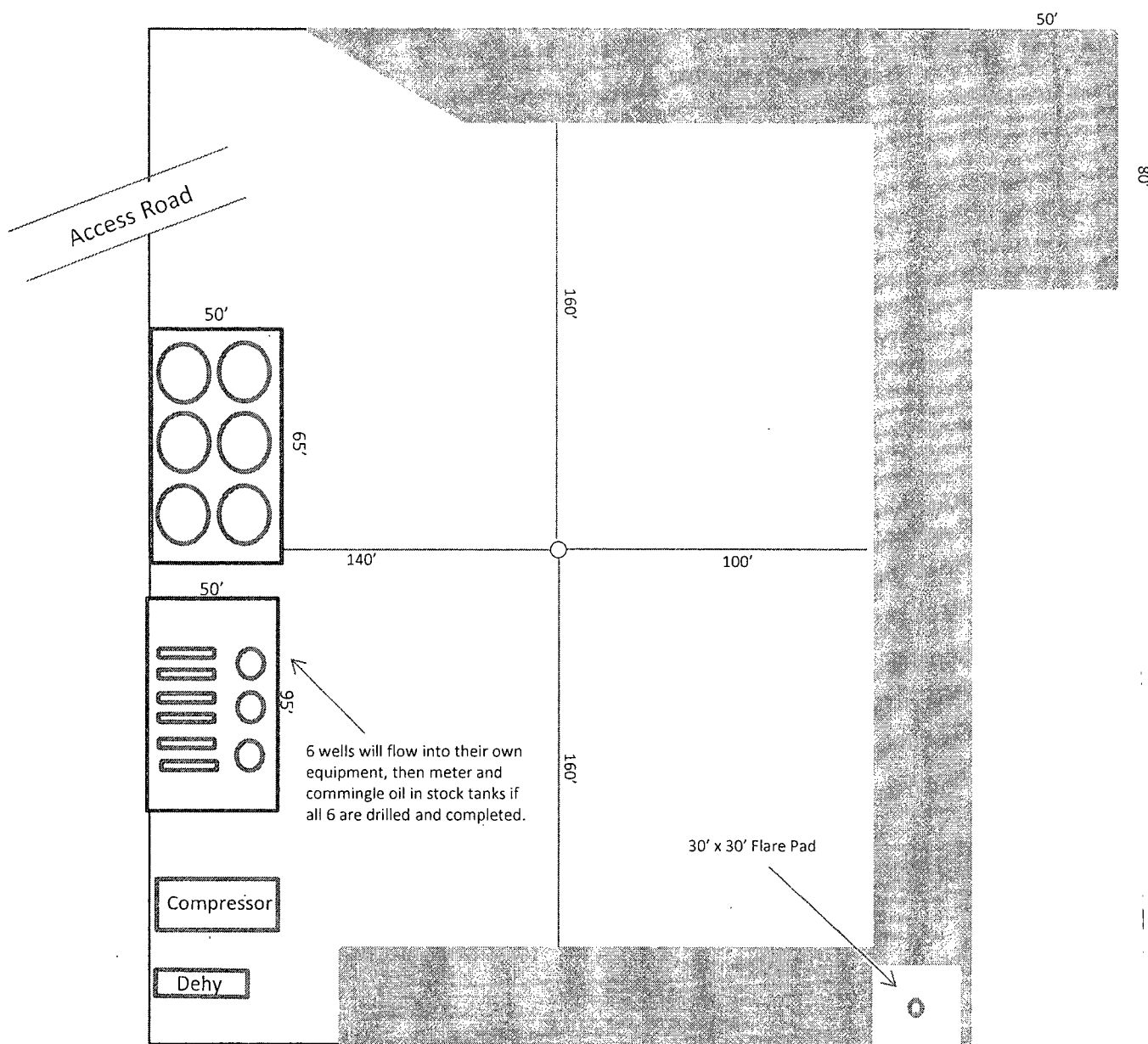


Exhibit D-1
