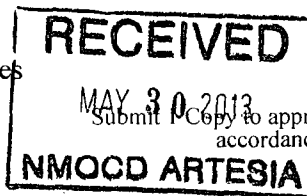

Fluids were contained in firewall. Two (2) BBLS of BS&W went outside of containment on ground. All contaminated soil was removed and replaced with caliche. All fluids were picked up and pumped back into the facility storage tanks. Pumped 100 BBLS of fresh water into firewall to help clean.
