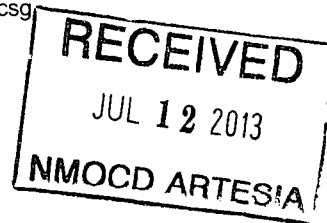

Mixed @ 15.6#/g w/1.19 yd. Plug down @ 11:30 PM 06/10/13. Did not circ cmt. Lift pressure @ 2200# @ 3 BPM. Ran temperature survey indicating TOC @ 1930'. Ran cased hole log from KOP to surface. Tested csg spool pack-off to 3500#. Tested BOPE to 3000# & annular to 1500#. At 6:30 PM 06/12/13, tested csg to 1500# for 30 mins, held OK. Drilled out with 6 1/8" bit.
