Spudded well on 6/10/13 w/12-1/4" bit. Drilled 12-1/4" hole to 445'. Set 8-5/8" 24# J-55 csg @ 439'. Cmted w/300 sx (405 cf) "C" cmt w/2% CaCl₂ & 1/8# cello flake. Circ 42 sx cmt to pit. On 6/12/13, pressure tested 8-5/8" csg to 1500 psi for 30 min - OK.

Drilled 7-7/8" hole to TD3157' on 6/14/13. On 6/14/13, set 5-1/2" 17# J-55 production csg @ 3157'. Cmted lead w/300 sx (570 cf) 35/65 poz "C" cmt w/5% salt, 6% gel, 2% R-3, & 0.125% CF & tailed w/350 sx (462 cf) cl "C" cmt w/0.5% PF-13, 2% PF-167, 0.2% PF-65, 0.125# PF-29. Circ 123 sx cmt to surface. Released drilling rig on 6/14/13. Plan to pressure test 5-1/2" csg before completion operations.
