Drilled 7-7/8" hole to TD4480' on 7/17/13. Set 5-1/2" 17# J-55 production csg @ 4475'. Cmted w/lead 280 sx (532 cf) 35.65 poz "C" cmt w/5% salt, 6% gel, 2% R-3, & 0.125# CF & tailed w/655 sx (871 cf) cl "C" cmt w/0.5% PF13, 2% PF-167, 0.2% PF-65, & 0.125# PF-29. Circ 67 sx cmt to pit. Released drilling rig on 7/20/13. Plan to pressure test 5-1/2" csg during completion operations.
