Mixed @ 15.6#/g w/1.18 yd. Plug down @ 4:00 AM 07/21/13. Did not circ cement. Ran temperature survey indicating TOC @ 900'. Ran cased hole GR/CNL from KOP to surface. Set wellhead slips w/200k#. Tested csg spool pack-off to 3000#. Tested BOPE to 3000# & Annular to 1500#. WOC. At 5:00 PM 07/22/13, tested csg to 1500# for 30 mins, held OK. Drilled out with 6 1/8" bit.
