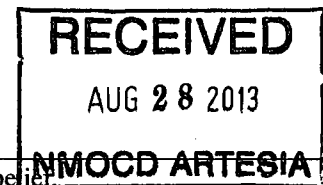

LRE OPERATING, LLC would like to change the 8-5/8" surface casing bit size to 11". The surface casing cmt required will also change to ~225 sx cmt.

We would also like to change the 5-1/2" production casing depth to ~4070'. The tail cmt on the 5-1/2" casing will increase to ~450 sx of cmt with the same additives.
