Tail w/350 sks Class C w/2% CaCl2. Mixed @ 14.8/g w/1.34 yd. Plug down @ 10:30 AM 09/08/13. Did not circ cement. WOC. Ran temp survey indicating TOC @ 122'. Ran 1" pipe in 1 stage with 25 sks Class C w/5% CaCl2. Mixed @ 14.8#/g w/1.34 yd. Circ 12 sks cement to pit. WOC. At 5:00 PM 09/09/13, tested BOPE & csg to 1250# for 30 minutes, held OK. Drilled out with 12 1/4" bit.
