BOPCO, L.P. respectfully requests to plug and abandon the Poker Lake Unit Big Sinks 24-25-30 #1H. Due to surface hole collapse and conductor parting, the hole will be plugged back from 1,130'. The plan for plug and abandoning PLU Big Sink 24-25-30 #1H will be to set a 400? plug from 730? - 1,130? using class C neat cement (14.8 ppg, 1.34 yield), this will place cement 50? above and below the rustler formation. After waiting on cement, we will tag the top of cement to verify the cement is at the desired height of 730?. After ensuring the first plug has been set and at the appropriate height we will then pump our second plug from 200? up to surface with class C neat cement (14.8 ppg, 1.34 yield) placing the conductor and 80? of formation behind cement.
