We ran 1" pipe in hole after Temp. log & tagged cement @ 186'.

Pump 83 sks.(20 bbls) of class C cement + 3% cacl. Yld. 1.34 cuft/sk water 6.35 gal/sk. Regain partial returns @ 18 bbls. cmt. Pump. (2 bbls. of spacer t/ surface) Pulled 1"; monitored sample 1 hr. (woc) Ran 1" in hole tag cement @ 110'; Pump (28 bbls) 117 sks of class C cement + 1% cacl. Yld.1.34 cuft/sk water 6.35 gal/sk . had 100% returns while cementing, had (8 bbls) 34 sks. of good cement to surface. Wait on cement 3 hrs. cut conductor; cement @ ground level.
