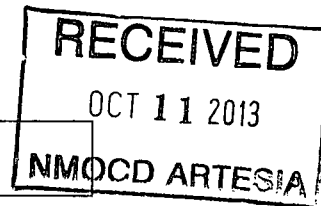

9/25/13 - Spotted 115 sacks (27 bbls) Class "C" cement at 1474. Did not circulate. WOC. Tagged cement at 1,251' 99 sacks cement went into formation. Spotted 85 sacks (20 bbls) Class "C" cement to surface. ND BOP. Topped off 4-1/2" casing with cement.

10/4/13 - Dug up cellar and cut off all wellheads. Installed dry hole marker as per OCD. **WELL IS PLUGGED AND ABANDONED.**
