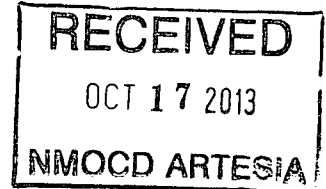

Gentlemen:

BOPCO, L.P. respectfully requests a pool transfer for the referenced well. When the Application for Permit to Drill was submitted, it reflected the well to be drilled and completed in the Nash Draw; Del/BS (Avalon Sand). The well was, in fact, drilled to the 1st Bone Spring Shale to a depth of 13816' MD (9060' TVD) and completed in that formation. This well was not logged but, based on nearby offset logs, the depth of the 1st Bone Spring is 8898' MD (8923' TVD), below the Lower Avalon Shale at 8247' MD (8245' TVD). The Avalon Shale and 1st Bone Spring Shale were inadvertently omitted from the Formation Markers listed in Item 31 of BLM Form 3160-4. This would have clarified the completion interval of the well was not in the Delaware or Avalon formations.
