

Yates Petroleum Corporation plans to Plugback and Recomplete as follows:

- MIRU all necessary safety equipment. ND tree and NU BOP. Release packer and TOH with 2-3/8 inch production string, scanalog the tbg out of the hole.
- Make a gauge ring and junk basket run down to 7,410 ft; then set a 4-1/2 inch CIBP at 7,400 ft and cap it with 30 ft of Class H cement.
- Perforate Canyon 7,012 ft - 7,020 ft (27).
- Acidize the perforations with 3,000 gallons of 20 percent HCL with 2 gal/M gelling agent, cationic surfactant, corrosion inhibitor and iron control additives. Flush to the bottom perf and over flush by 25 bbls. Swab test and evaluate. NOTE: If the zone appears to be unproductive then TOH with tbg and tools and continue to the Abo Completion below.
- TOH with the tbg and tools. TIH with production packer and tbg, set the packer at 6,900 ft. Turn the well over to the Production Department.


