

1. RIH with 2" pipe to bottom of casing
2. Pump Class "C" Cement until full returns to surface
3. POOH with 1" and wait 15 minutes and monitor well for fall back
4. Top out well with cement
5. Install 4" P & A marker per BLM requirements

Tag Bottom of well bore, circulate cement to surface. At cut-off verify cement to surface on all annulus. If not take remedial action.
