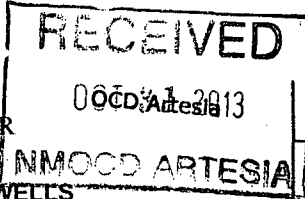

Spudded well on 9/14/13. Drilled 12-1/4" hole to 360'. Set 8-5/8" 24# J-55 csg @ 352'. Cmted w/335 sx (452 cf) cl "C" cmt w/2% CaCl₂, 0.005# static free, & 0.25# C/F. Circ 125 sx cmt to pit. On 9/16/13, pressure tested 8-5/8" csg to 1500 psi for 30 min-OK.

Drilled 7-7/8" hole to TD5050' on 9/19/13. Set 5-1/2" 17# J-55 production csg @ 5048'. Cmted w/lead 280 sx (540 cf) 35:65 poz "C" cmt w/5% PF-44, 6% PF-20, 0.2% PF-13, 0.125# PF-29, 0.4# PF-46, & 3# PF-42 & tailed w/650 sx (871 cf) cl "C" cmt w/0.5% PF13, 0.2% PF-167, 0.4% PF-46, & 0.125# PF-29. Circ 29 sx cmt to pit. Released drilling rig on 9/20/13. Plan to pressure test 5-1/2" csg during completion operations.
