Tailed in with 180 sacks 50/50 Poz C + 42 lb/sx D035 + 5 percent D044 + 0.2 percent D046 + 0.05 percent D208 + 47 lb/sx D903 (yld 1.34, wt 14.2). Bumped plug to 1700 psi, held OK. Circulated 173 sacks to pit. WOC 32 hours. Reduced hole to 8-3/4 inch and resumed drilling.
