11-15-2013 MI&RU Basic Energy. POH with tubing and rods. RIH with 5-1/2" CIBP set at 4180'.
11-18-2013 RIH with tubing, tag CIBP at 4180'. Pump truck circulated 30 bbls. brine and 8 sacks gel. Spot 25 sacks Class C cement 4180'-247'=3933'. Displaced with 22.77 bbls. and 5 sacks gel. RIH with wireline and 5-1/2" CIBP, set at 3100'.
11-19-2013 Circulate well with 60 bbls. brine and 15 sacks gel. Spot 25 sacks Class C cement 3100'-247'=2853'. Displaced with 16.5 bbls. and 4 sacks gel. RIH with wireline, perf. at 950' with 4 shots. RIH and set packer at 590', pressure test to 800 psi, held 15 mins. okay. Unset packer. RIH to 1000'. Spot 25 sacks Class C cement 1000'-247'=753'. Displaced with 4.35 bbls. WOC 4 hrs. RIH, tag cement at 765', okay. RIH and perf at 484' with 4 shots. RIH to 130', set packer, pressure test to 800 psi, held 15 minutes okay.
