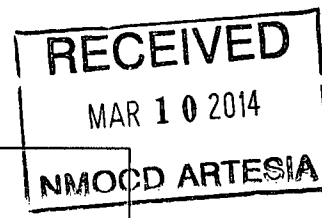
BOPCO, LP submits this sundry notice to report the referenced well was returned to production on February 15, 2014.
