

The proposed plan is to construct 1-4 inch flex pipeline located on the surface in Section 21, Township 17 South, Range 28 East, Eddy County, New Mexico. The line will transport produced water from the Artesia Yeso Federal Unit Central Tank Battery to the Yeso SWD Well. Construction should begin within 30 days of BLM approval.
