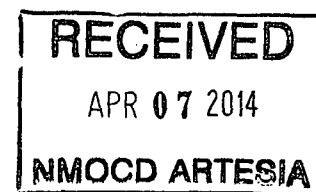

The Gissler B 14 has a braden head water flow that needs to be fixed. A CBL has been run and TOC is not clear, something appears to be behind the production string at the surface but only for a few hundred feet.

While trying to test casing, a casing leak was found in the surface casing. The surface casing needs to be dug out until good pipe is found and new surface casing can be installed from that point up. After good pipe is found, check annulus for cement between surface and production casing. The new casing will be 8 5/8" 24# LT&C J55 casing with 1.125 CDF, 1.00 BDF and 1.80 TDF.
