ConocoPhillips would like to amend the setting depth of the 9 5/8" string (Intermediate 1) for the subject well. The 9 5/8" string (Intermediate 1) was approved to be set at 3,925'. We propose to drill to 4,125' and set the casing at ~4,115'. This would be just inside the Ford Shale member of the Delaware. The cement volumes would be adjusted accordingly.

The well is scheduled to estimated spud on April 2, 2014.
