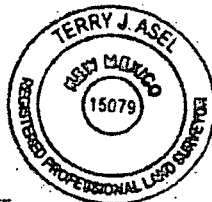


Base of Bearings - GPS Geodetic Measurements

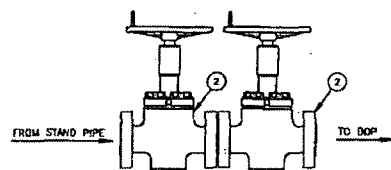
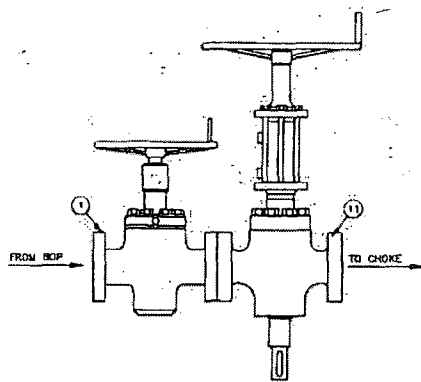


SENM 2-String Wellhead

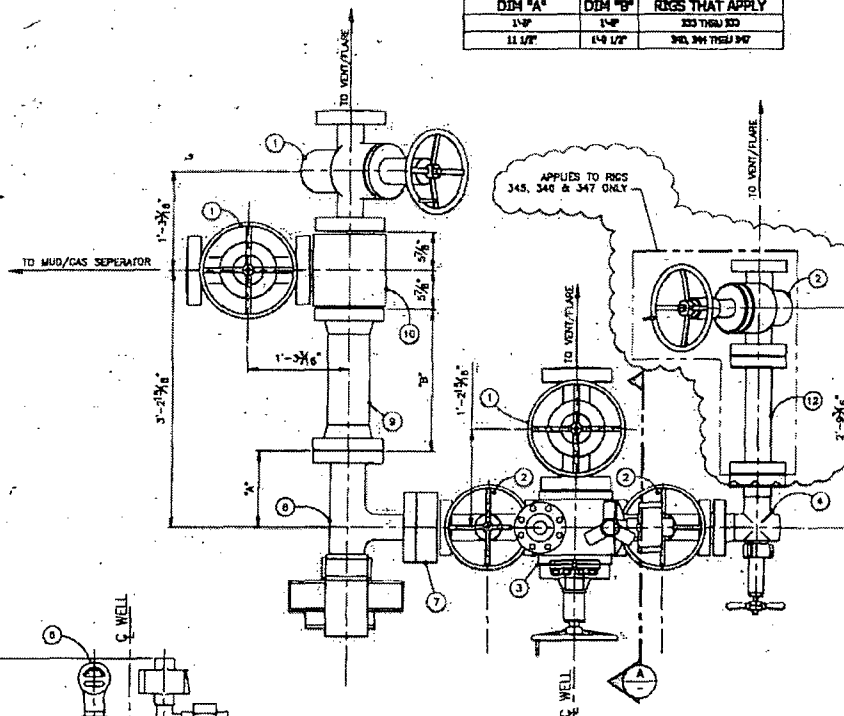

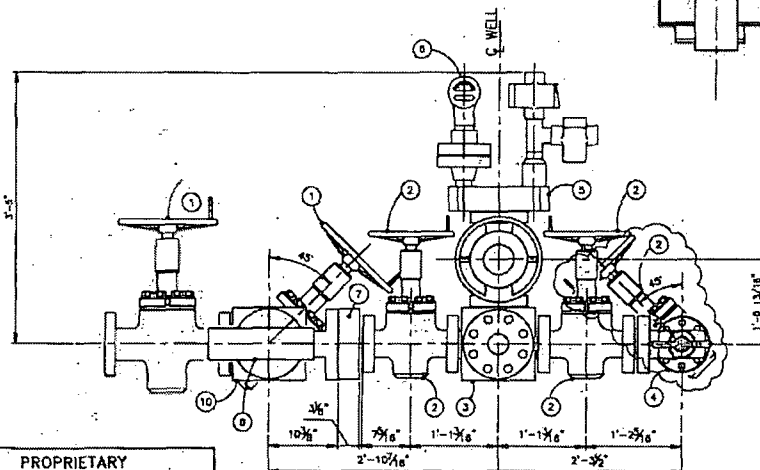




BOP SIDE OUTLET VALVES



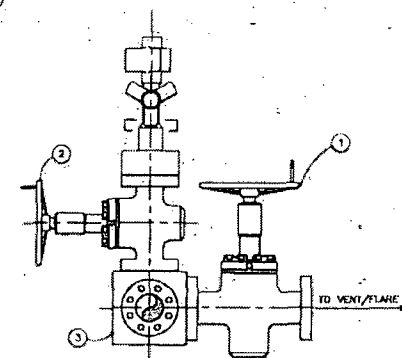
PLAN VIEW
