

This work was done, after obtaining verbal approval from Randy Dade to set a cmt plug on top of the fish @ 6901' & sidetrack a 6-1/8" hole around the fish to TD.

On 3/24/14, pumped 115 sx "H" cmt @ 6901'. On 3/25/14, started drilling cmt stringers @ 6374'. Drilled cmt through 7" shoe @ 6650'. Initiated sidetrack 6660'-80' & drilled 6-1/8" hole to TD8429'. Released drilling rig on 4/5/14. We plan to log the open hole during completion operations.
